- Holiday Bazaar:

Principal's Report: Amy

- Holiday Bazaar was wonderful and so fun! Thanks to all the volunteers and those that donated items; great way to kick off the holiday season
- Opera is this Thursday; students have been practicing Tuesdays and Thursdays, and we are all looking forward to the performance
- Kinder Tour Wednesday 12/6; will roll out communications for additional tours in early 2024
- TK 2024: same answer as we've had; it depends on enrollment; will have to see how many sign up at each site
- Spelling Bee is coming up! Teachers will be handing out practice lists this week, and will administer the classroom bees between 12/18-21; top 10 from each class will participate in the schoolwide Spelling Bee on January 22 (this is optional for all students)

Discussion Items:

- Playground remodel update
 - Will bring in community to help decide, and open to the school wide parent community to vote on
 - Will have Spec come in January
- Spring Book Fair
 - We need to decide what we would like to do in the Spring for a Book Fair, since Literati told us we cannot use them again (we didn't meet their \$6000 minimum for our Fall Book Fair)
 - Scholastic reached out stating they still have us booked for March; stated they have updated their registers
 - We will be trying something new with Ink Spell in March: they will set up a book sale for 3 days, with books \$1-\$5. We haven't set up dates, but will be in March
 - We would like to try Ink Spell to see how it goes, along with a book swap, so we will say no to Scholastic for Spring; we will book a week in Fall 2024 to hold the dates
- March Reading Madness
 - For Authors coming in March for March Reading Madness we can look into ordering their book for them to sign and provide to all students
 - One author has offered to bring a book for each student and sign them
- This past Thursday Sunday, Ink Spell was going to provide us a portion of sales for those that said "Whiskers" with their purchases; haven't heard back
